Christiana Fire Company Part Time Employment Opportunity

Nature of Position: Part-time employees will be responsible for staffing the basic life support ambulances on a daily basis, providing emergency medical care and transportation. During fire suppression activities, part time employees must be able to utilize hose lines, ladders and perform duties while wearing self-contained breathing apparatus. Part-time employees will only be utilized for fire suppression activities when it is necessary for them to complete a crew.

Responsibilities will also include: Routine checks on equipment and tools, light vehicle maintenance, administrative functions and logistical support as needed.

Part-time employees must show initiative at promoting a team concept. Part-time employees must pass a criminal background check, reference verification and submit a complete driving history. Part-time employees should be able to lift a minimum of 75 lbs.

There will be a ninety (90) day probationary period for this position.

Hours of Work: 0600 – 1800 or 1800 – 0600 (subject to change)
No more than 24 consecutive hours
No more than 36 hours in a pay period (Sunday – Saturday)

 - Be at least 19 years of age
 - A U.S. citizen or documented proof of work eligibility
 - Non-member of the Christiana Fire Company

- High school graduate or GED equivalent
 - Possess a valid Delaware Class “B” Non-CDL Drivers License AND Emergency Vehicle Operator Certification
 - Provide a Certified copy of driving record (to be submitted with application)
 - Provide documented proof that a criminal background check has been requested from the Delaware State Police (to be submitted with application)
 - Excellent written and oral communication skills
 - Highly dependable, responsible and reliable
 - Must have working knowledge of applications to complete various reports, including use of EDIN/DIMES and Firehouse software systems
2. Part Time applicants MUST HAVE COMPLETED and PROVIDE DOCUMENTED PROOF of the following requirements:
- NREMT-B & State of Delaware EMT-B
 - Minimum 6 months practical experience
 - Current Healthcare Provider CPR Certification and AED
 - Basic Firefighting Skills (FIRE I) or equivalent
 - Structural Firefighting Skills (FIRE II) or equivalent
 - Hazardous Materials Response Skills or equivalent
 - Vehicle Rescue or equivalent
 - Crew Leader or equivalent
 - Driver/Operator or equivalent
 - Defensive Driving
